Children's Aid Society, a ministry of Southern Pennsylvania District Church of the Brethren, is a not-for-profit agency committed to helping children and their families build stronger, healthier lives through the provision of loving, professional services.

Art Therapy is provided to children experiencing significant life events, including conflict, divorce, school problems, abuse and behavioral issues. Two Board Certified, Registered Art Therapists and three additional Art Therapists working toward their professional certifications help children in the healing process. In addition, a Licensed Social Worker provides Play Therapy.

4b (Code:) (Expenses \$ 448,280. including grants of \$) (Revenue \$ 442,491.)
The Crisis Nursery provides 24 hour emergency and temporary respite care for children birth through six years of age. Children stay at the center for up to 72 consecutive hours while their parents work toward the resolution of their crisis.

4c (Code:) (Expenses \$ 86,080. including grants of \$) (Revenue \$ 29,628.)
Family support and advocacy services include Case Management to families via office and/or home visits, and developmental screenings, which provide useful information regarding delays of the children and the need for specific services.
